# Michael Kelly – President Southern Gold Coast Chamber of Commerce

It seems like only a short time ago we gathered for our last Annual General Meeting, and yet here we are once again! Since then, we've not only maintained stable membership numbers but also experienced growth in our total asset base, which our Treasurer will delve into further in the upcoming report. I'm pleased to announce that we continue to be in a strong financial position, which is a testament to our collective efforts and commitment.

#### Events:

At the start of the year, the Board committed to a strategy focused on maximising the value of our events, and I'm pleased to say that we've made significant strides in this area. Over the course of the year, we hosted a total of 12 events, with an impressive average attendance of 90 people at each.

Among these were a number of sold-out events, including the unforgettable breakfast at the new facility within Currumbin Wildlife Sanctuary—The Homestead—where John Warn from Experience Gold Coast delivered a fantastic presentation. We also organised several "After Dark" events, such as the highly successful evening at Lucia Tapas Bar. Additionally, our breakfast events covered a range of interesting topics this year, with presentations from key figures such as Gold Coast Airport and presentations from the education sector.

On top of these, we hosted three mental health workshops tailored for businesses, presented by the local charity LIVIN. These sessions provided practical tools for addressing mental health challenges in the workplace, reflecting our ongoing commitment to the well-being of our business community.

# Membership:

Over the past year, we've seen remarkable growth in our membership, with a 31% increase, surpassing our strategic goal of 20%, which is a true testament to the strength and appeal of our Chamber.

In addition to growing our numbers, we also set a strategic objective to improve member retention, and I'm pleased to say that we've achieved that goal as well. Even more businesses have come on board as Gold, Silver, and Bronze members, with a record 62 Gold members now supporting our Chamber. In July this year, we hosted the inaugural President's Lunch at Kirra Beach House, a special event designed to recognise the support of our Gold Members. This unique gathering brought together top-tier leadership within the Southern Gold Coast business community, solidifying its place as one of the city's premier executive-level networking functions.

We've also continued to nurture our relationship with the Gold Coast Junior Chamber of Commerce, co-hosting events that engage and attract the next generation of business leaders. Looking ahead, we are eager to bring more young professionals into the Southern Gold Coast business community, helping them find opportunities to grow and thrive.

Finally, we've renewed our focus on the overall member experience by investing in people. One key example is our Chamber Administrator, Kylie, whose efforts have significantly supported the Board throughout the year. Her contributions have been invaluable, helping us deliver an even better experience for all our members.

# Advocacy:

In the area of advocacy, we have remained steadfast in our efforts to represent the interests of our members and the wider business community. We continued to provide regular updates through various media channels, ensuring a strong voice of our business community.

This year, we held a series of events and welcomed speakers who focused on important advocacy topics. These included the changes industrial relations, migration, education, and local government matters—issues that are crucial to both our community and businesses.

We also actively participated in consultations and made a formal submission on the first tranche of changes to the IR legislation, ensuring that the voices of our members are heard and considered in these important legislative discussions.

In the areas of Communication and Organisational Development, we have made significant strides this year. To drive progress and ensure a collaborative approach, we established several working groups that have been instrumental in aligning our efforts with our broader organisational goals.

Additionally, we established a comprehensive marketing plan, ensuring that our messaging is consistent and that we continue to engage effectively with our members and the wider community. These efforts have laid a strong foundation with significant improvements planned in the coming months.
